#### **PREFACE**

Rani Channamma University, Belagavi, is a public university established by the Government of Karnataka in 2010 at Belagavi, with the jurisdiction of Belagavi, Vijaypura and Bagalkot districts. It was created by upgrading the then Kittur Rani Channamma Post Graduate Centre, Belagavi, of Karnataka University, Dharwad, in 1982. It is named after Kitturu Rani Channamma, the queen of the erstwhile princely State of Kittur in Karnataka. The main aim of the University is to provide an opportunity to develop access to higher education for students hailing from North Karnataka Region which is deprived of good educational facilities. In tune with the National Higher Educational Policy the University is striving to meet the challenges of increasing Access, Equity, Quality, Affordability and Accountability. Rani Channamma University has the main campus, "Vidyasangama" as its headquarters, on 172 acres of picturesque land near Bhutaramanahatti, adjacent to the Pune-Bangalore National Highway-4 about 18 km from Belagavi city. The University has 20 Post-Graduate Department of Studies in the faculties of Arts, Science, Commerce and Management and Education offering 25 Post Graduate programs imparting higher education on the main campus to more than 2000 students. Also, 28 P.G. Degree/Diploma courses are offered in 66 affiliated colleges/Institutes of the University. There are 385 affiliated colleges, 1 constituent college and 3 autonomous colleges with enrolment over one lakh fifty thousand students in the UG, PG and Doctoral programmes. CBCS is also in place at the PG level. The Ph.D. programmes are offered in all the P.G Departments. So far 85 Ph.D. degrees and 5 D.Sc/D.Litt has been awarded. Also, during last 3 years 100 students have cleared the NET/SLET. Four specialized Study Chairs are functional, viz. Dr. B.R. Ambedkar, Rani Channamma, Pandit Deen Dayal Upadhyaya, and Sangolli Rayanna.

It is important to note that the University has been making attempts to switch over to School system to enable inter-disciplinary learning, teaching, and research:

University has been trying hard to achieve academic excellence right from inception. Recommendations of the task force constituted under the Chairmanship of Prof.M.I. Savadatti, former Vice-Chancellor, Mangalore University has immensely helped the University in the formative years. Academic and Administrative Audit (AAA) has been conducted once in every two years, the first one has been conducted in March-2014 and the Second one in May-2016. Now the University is preparing to go through its 1st cycle of NAAC accreditation in the year 2020. In this context, the University has constituted Academic Administrative Audit Committee in accordance with the NAAC norms consisting of the following members:

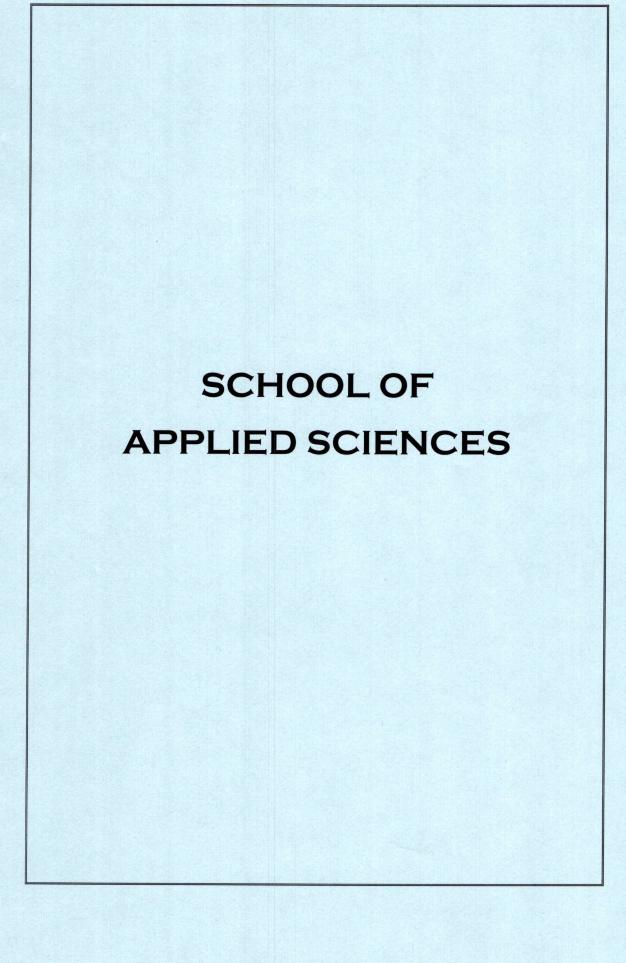

# a. Strengths:

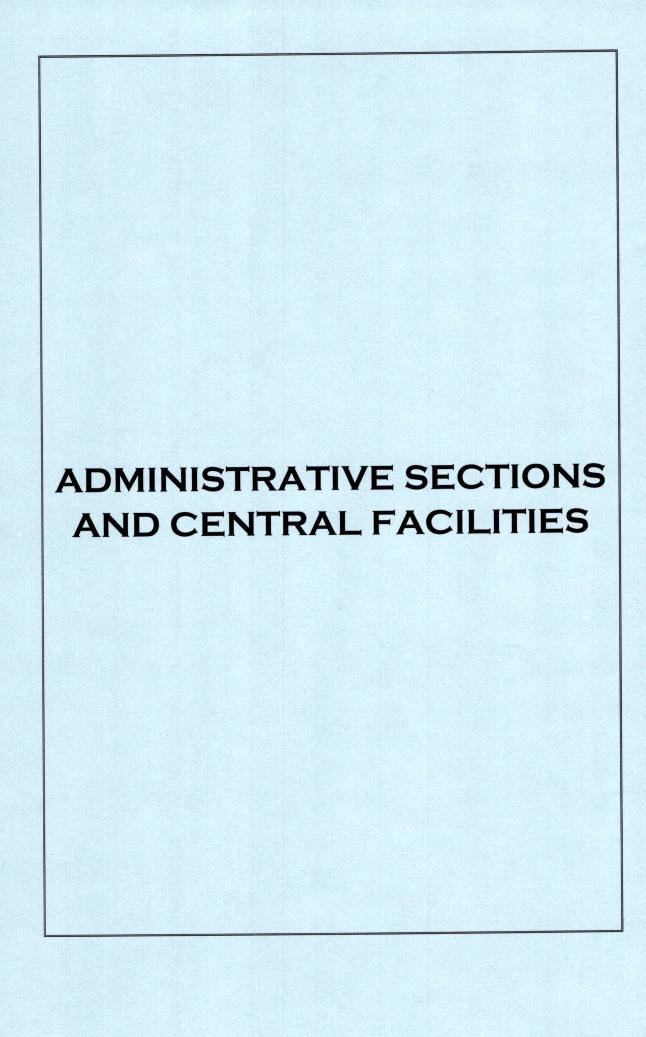
- 1. The faculty have attended refresher and orientation courses.
- 2. Students have secured ranks in PG examinations.
- 3. Only two publications by the faculty.
- 4. Social awareness programmes conducted.

## b. Limitations:

- 1. Admission is low in 2017-18 and 2018-19.
- 2. Placement improvement.
- 3. No effort made to submit research projects.
- 4. The centre has inadequate physical infrastructure.

#### Recommendations:

- 1. Efforts should be made to conduct seminars & conferences.
- 2. Project proposals should be prepared.
- 3. Faculty should undertake publication of articles and books.
- 4. Special lectures by eminent persons be organized.



#### **REGISTRAR'S OFFICE**

The office of the Registrar seems to be equipped with necessary staff and IT facility for smooth functioning. It has kept itself abreast of things and has up to date information about the issues it deals with. Officials were able to give answers on all the issues about which detailed information was sought. The staff looked technologically trained as staff recharge programmes were conducted twice. All RTI applications are sorted out and needed information given to the applicants. Transparency seems to be ensured. Grievances of the stake holders are addressed within the stipulated time. The Sakala initiative of the GOK is fully adopted.

Out of 120 sanctioned teaching posts, 96 posts have been filled and going by the relative figures in other universities, this is appreciable. As regards the non-teaching staff is concerned, out of 272 sanctioned posts, 137 are in place. The administration feels that the position is satisfactory and there is no pressure of work warranting additional recruitments.

The CAS promotions of staff are carried out regularly. The ICT initiatives for effective e-Governance in university are visible and appreciable. At present the work of the Registrar Evaluation is also looked after by the office of the Registrar, supported by the support staff. One very good thing about the functioning is that there does not seem to be internal bickering in the general administration wings.

## **REGISTRAR EVALUATION**

#### Observations:

- 1. Adequate staff is in charge of the work.
- 2. IT infrastructure is appreciable.
- 3. Minimum time taken for the announcement of results after the conduct of examinations.
- 4. Percentage of students applying for revaluation in UG and PG examinations is negligible.
- 5. Adequate steps taken to ensure safety and security of marks cards and degree certificates.

#### Recommendations:

- 1. Digital valuation process be initiated for both UG and PG examinations.
- 2. Malpractices Enquiry Committee be reconstituted to include dean as Chairman for different faculties.
- 3. Guidelines be prepared to rationalize penalties for examination malpractices.

#### **FINANCE OFFICE**

#### Observations:

- 1. 14 permanent, 7 temporary staff are working in the Finance office.
- 2. All payments are made through NEFT/RTGS which is a good practice.
- 3. Books of accounts are properly maintained.
- 4. Audit of accounts up to 2017-18 are carried out by Government auditors. Audit objections seem to have been adequately answered.

#### Recommendations:

- 1. Digitization process has to be further strengthened.
- 2. Serious efforts be made to obtain higher grants from the UGC.
- 3. The university should focus on obtaining funds from the corporate sector under CSR scheme and also from philanthropic bodies.

# **BUILDING SECTION AND ESTATE OFFICE**

Estate section is organized into three sections. They are Engineering, Estate and Garden. While engineering section looks after constructions and maintenance, procurements, equipment's are under the control of Estate section. On the other hand Garden section takes care of plantation. 14 employees are working who include engineering staff and supporting staff. Efforts have been made to submit all the necessary documents like shape plans to respective authorities for clearance of land. Efforts are also made for identification of alternative land. The work of Estate section is commendable. They need more office space.

#### **CENTRAL LIBRARY**

## Observations:-

The University Library occupies 3760 sq ft area in the ground floor of main building of the University and caters to 18 PG Departments. It provides reading space for maximum of 70 students and also Green library (open reading space) has been created. It has a collection of 49, 214 books and 87 Journals with 3928 book volumes. It provides for online resources: indianjournals.com, e-Shodha, DELNET, WORLD e-book Library and National Digital Library. The library services include OPAC, SC/ST Book Bank, OBC Book Bank, Issue of bar coded books, Newspapers, Wi-Fi enabled services. There is a good usage of Library Services from students and faculty.

#### Recommendations:

The Library suffers from lack of adequate space due to limited building space. The measures shall be taken to enhance and support virtual Library, procurement of e-Book and e-learning resources to cater to the urgent needs of the students and faculty. The Library should be manned by adequate number of permanent qualified staff. The facilities shall be provided for People with Disabilities (PWD) on priority.

#### COLLEGE DEVELOPMENT COUNCIL

#### Observations:-

- 1. An experienced faculty is in the charge of Director, College Development Council. The office staff is adequate and efficient.
- 2. The Affiliation process has been carried out as per the calendar prescribed by the State Government and under KSU Act 2000.
- 3. The University has 372 affiliated colleges, and the renewal of affiliation of such huge number is really challenging. The CDC has been efficient in this task.

### Recommendations:

CDC should take proactive research in organising workshops;
 Seminars/Workshops pertaining to NAAC of colleges, AISHE, UGC Grants
 Scheme, RUSA scheme etc for affiliated colleges.

- 2. Measures to be taken for on-line affiliation
- 3. College Development Council (BOARD) has to be constituted as per the Act and Statutes and be made functional.

#### **GYMKHANA**

#### Observations:

## a. Strengths:

- 1. Undertaken unique activities for cultural development.
- 2. Provided wonderful opportunities for exhibiting talents.
- 3. 80% funds are utilized.
- 4. Conducted various sports events.
- Following democratic process in electing the student representative to Gymkhana.

#### b. Limitations:

Yet to win state level/national level prizes/awards in cultural and sports activities.

#### Recommendations:

- 1. Sprawling sports grounds have to be provided.
- 2. Specialized coach/instructors have to be appointed to unleash sport talents.
- 3. Participation in national sports and cultural events to be promoted.

## **HEALTH CENTRE**

## Observations:

- A health centre with two doctors on contract basis with minimum facilities is available for the benefit of girl students. A Health Centre for male staff and students is located in boys' hostel.
- 2. Day to-day register of Patients is maintained.
- 3. Free medical camps are organised for the benefit of students and staff.
- 4. Free medicines for ordinary ailments are provided.

#### Recommendations:

- A full-fledged Health Centre with facilities for in-house treatment for minor ailments should be established with at least two doctors (one lady) appointed full time.
- 2. The Health Centre needs to be located in a place/floor which is easily accessible and having an independent building.

#### **HOSTELS**

#### Observations:

The University has two Boys Hostels: Brahmaputra Hostel and Krishna Hostel, with 100 rooms with a total capacity for 240 students/ The University funds along with SC/ST, OBC and EBL funds is provided for catering to the needs of the SC/ST & OBC students. The boarding facility is provided on contract mess basis at Government fixed rates. The general hygiene is maintained.

#### Recommendations:

The Hostel facility shall be provided for women students on priority basis with adequate facilities. The hostel facility should be enhanced by constructing or acquiring on rental basis the hostel buildings, in order to increase the enrolment of rural students in the various PG Departments. A separate hostel for research scholar be constructed for promoting research activity of the University.

## LEGAL AND RTI CELL

The Legal and RTI cell is established in the year 2014. It is functioning under one Law Officer appointed by the university to look after the legal cases admitted in the court as well as the RTI applications received by the university. The cell provides for appointment of advocates on legal panel and related matters as well as the constitution and appointment of Public Information Officers (PIOs) and Assistant Public Information Officers (APIOs) as per provisions of RTI Act.

The cell is effective in responding to RTI applications. However, it needs to do more efforts in disposing off the pending writ petitions at the earliest possible.

### National Service Scheme-NSS

#### Observations:

## a. Strengths:

- 1. NSS is in existence since 2011-12 and functioning well.
- 2. It has a good organizational structure with an Advisory Committee.
- 3. Instituted awards for best Programme Officer.
- 4. Organizing special residential camps in adapted villages.
- Extension programmes such as AIDS awareness programmes, Swachh
  Bharat Abhiyan, PM Jan Dhan Yojana, Drug Addiction Eradication
  programmes, Gender sensitization programmes are regularly conducted.
- 6. NSS volunteers took active part in flood relief camps.
- 7. Few students participated in Republic day celebration.

#### b. Limitations:

- 1. Inadequate office space.
- 2. Yet to win State level/National level awards in NSS programmes.

#### Recommendations:

- 1. Good office space be provided for efficient working.
- 2. Some more staff be appointed as the volume of work is increasing.

## **OBC** Cell

The OBC cell is functioning since the inception of the university and is supported by administrative staff comprising 01 Coordinator, 01 Assistant Registrar, 01 FDA, 01 SDA and 01 Attender. It facilitates and administers the Central and State Government benefits and schemes for other Backward Classes (OBC) and Minorities students enrolled in the University PG departments on the Main Campus as well as all the three PG centers. It provides Government scholarships, hostel facilities, Education Loans through Banks/Financial Institutions and Karnataka Minority Development Cell (KMDC) to the OBC and Minorities students pursuing higher education and research work in the university. The OBC cell is active and effective in its functioning, supported by ICT as a part of e-Governance initiatives under taken by the university.

It is necessary that university establishes as early as possible an Equal Opportunity Cell as mandated. It is further advised to keep track of the alumni and also enlist their cooperation and support for the further generation of needy students of these communities.

#### **PRASARANGA**

#### Observations:

Prasaranga is functional with a Director, Assistant Director and a non-teaching staff. It has published 47 Kannada text books, eight annual reports and three other books in Kannada. The Prasaranga above organises Endowment lectures annually. It has arrangement with a Publishing House to bring out its publications. It should develop to be an important face of the University.

#### Recommendations:

- 1. Extension activities may be arranged annually in collaboration with different likeminded organisations, colleges and the lecturers/speeches delivered by experts be published.
- 2. A research journal covering the different disciplines offered by the University may be published.
- 3. A newsletter highlighting the activities of the University be published periodically.
- 4. A volume containing lectures organised by the departments be published to mark the ten years of existence of the University.
- 5. A certain number of English versions of the annual reports and other key publications be brought out.

## SC/ST Cell

The SC/ST cell is functioning since the inception of the university and is supported by administrative staff comprising 01 Special Officer, 01 FDA, 02 SDA and 01 attender. It facilitates and administers the Central and State Government benefits and schemes for SC/ST students enrolled in the university PG departments, on the main campus as well as all the three PG centers. It provides Governments scholarships,

hostel facilities, Book-Bank, Laptops, IT training and coaching for Competitive Exams to the SC/ST students pursuing higher education and research work in the university.

The SC/ST cell is active and effective in its functioning, supported by ICT as a part of e-Governance initiatives undertaken by the university. It is advised to keep track of the alumni and also enlist their cooperation and support for the future generation of needy students of these communities.

#### SPORTS SECTION

#### Observations:

The University Sports section is functioning since the inception of the University in 2011 under the supervision of I/C direction of Physical Education and Sports. It is also over seen by the co-ordinator, who is deputed from constituent college of University. The sports section is actively engaged in organization of University level, State-level and National-level sports events and also facilitates student participation in such events. The participants have won some prizes/medals at State and National level competitions, which is commendable. At present, the sports section is making use of ground facility and coaching/Training facilities of Government District Stadium as well as that of affiliated colleges.

## Recommendations:

The adequate qualified permanent staff shall be appointed. Also ground facility and Coaching/Training facility shall be created on the main campus of the University.

## STUDENT WELFARE

#### Observations:

## a. Strengths:

- 1. Wide varieties of welfare programmes were conducted.
- 2. Well-coordinated with NSS, Gymkhana and Hostel.
- 3. Redressed grievance from time to time.
- 4. Initiated entering MOU for career building.
- 5. 1, 08,500 UG and 4600 PG students are serviced.

#### b. Limitations:

Inadequate office space.

#### Recommendations:

- 1. Student welfare cell to address grievance be strengthened.
- 2. Organize psychological counselling to students to develop mutual understanding which in turn reduces grievances.
- 3. Mentoring teams shall be formed with teachers and students in the ratio of 1:10.
- 4. Separate office space and facilities are to be created.

# WOMEN EMPOWERMENT CELL (WEC)

## Observations:

# a. Strengths:

WEC is established in 2012 and is well structured as per UGC guidelines. It has Internal Complaint Cell. It carries out activities in respect of skill development, self-reliance, health & hygiene, social outreach. It has adopted two villages for its activities.

### b. Limitations:

There is no building space. Adequate funds are not available for WEC activities. The initiatives leading to research projects are not visible.

## Recommendations:

The WEC shall undertake Govt./Pvt. funded research projects related to women empowerment issues and other matters of contemporary relevance. Linkage with Govt. schemes and Bank schemes for Women Empowerment (eg. Stree Shakthi, SHG, etc.) need to be established. The WEC activities shall be made more visible by encouraging larger student and faculty participation.

#### YOUTH RED CROSS CELL

#### Observations:

# a. Strengths:

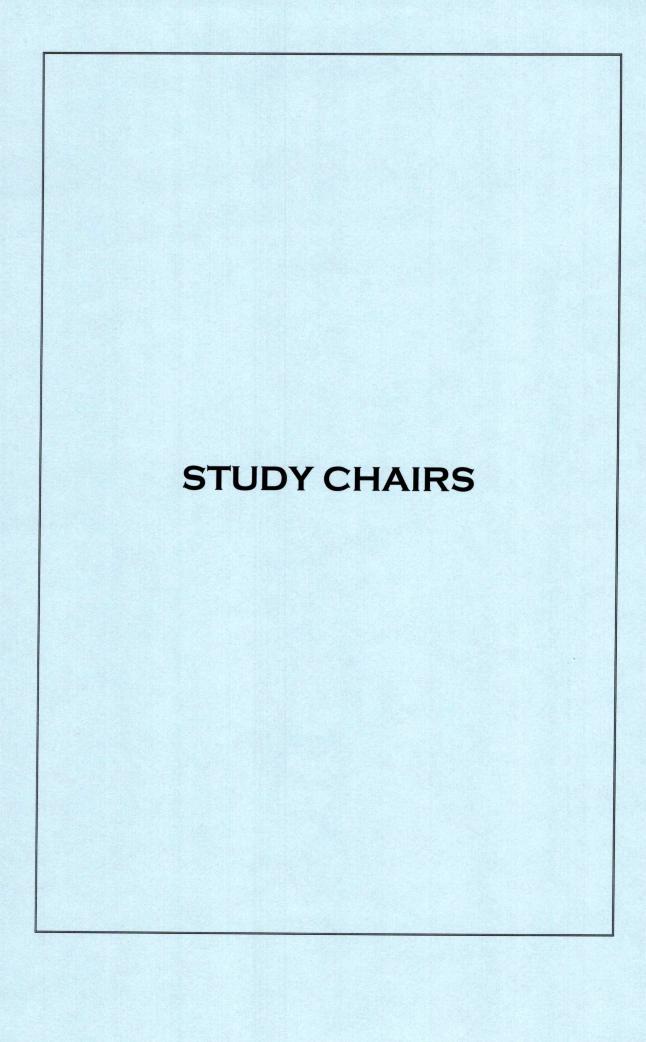
The Youth Red Cross Cell is functioning as per the state government and Red Cross Society guidelines. The cell is engaged in activities such as blood donation camps, motivation camps, Swachh Bharat Abhiyan, Orientation and Training camps etc regularly. The cell has maintained list of voluntary blood donors on the university campus. The students training in First aid is also organized regularly. The students have secured second prize in state level quiz competition in 2018.

## b. Limitations:

- 1. There is no building space.
- 2. The student and faculty participation is limited.

## Recommendations:

More building space and infrastructure facility shall be provided. The cell shall organize activities to sensitize students about traffic rules with support from RTO and Traffic Police.



#### DR.B.R.AMBEDKAR STUDY CHAIR

The Dr. B. R. Ambedkar Study Chair was established in 2017 in the university by the Government of Karnataka's Social Welfare Department. The chair has one Director and a Coordinator to carry out the activities of the chair. One year diploma course is offered by the centre. During 2017-18 14 students joined the course, while the admission went up to 53 during 2018-19.

The chair has published 04 books and organized essay writing competitions, special lectures, Elocution Competitions etc.

#### Recommendations:

- The chair should expand its activities by inviting scholars of eminence who
  have carried out extensive research on Dr. Ambedkar's ideas to deliver special
  lectures.
- 2. At least one national Seminar be organized in a year on the Socio-Economic and Political ideas of Dr. Ambedkar and the proceedings be published in book form.

## DEENDAYAL UPADHYAYA STUDY CHAIR

The Chair was established in June 2019 by the Government of Karnataka with financial assistance from Government of India. The chair has a Professor, one Assistant Professor and a Research Assistant, along with the required non-teaching staff. The chair, with the help of an Advisory Board, has drawn up a list of activities to be carried out.

#### RANI CHANNAMMA ADHYANA PEETHA

The Peetha was established in 2018; however it started working two months ago. The Peetha has drawn up an exhaustive list of objectives to undertake studies and research on the life, work and messages of Rani Channamma. It has one Director, one Coordinator (both teachers holding additional charge) and research fellows and one clerical staff. Rani Channamma Jayanti was organized on November 13, 2019

#### Recommendations:

1. The Peetha's Advisory board may have experts to guide its working from across disciplines.

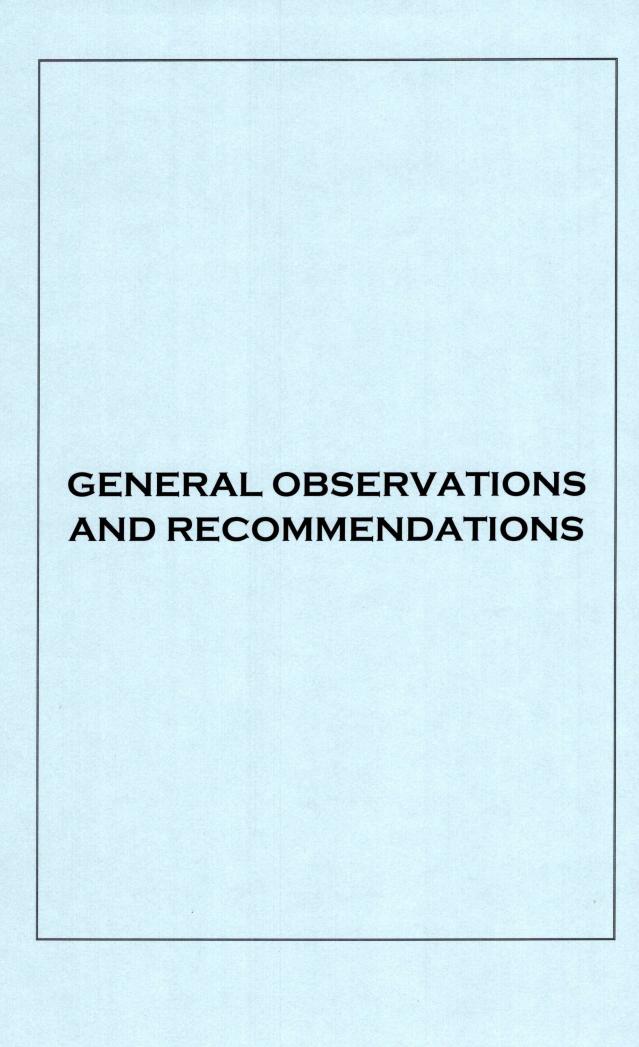
- 2. Diploma and certificate courses be started in relevant areas with due deliberation.
- 3. Research on the role played by Rani Channamma in the freedom struggle be undertaken and its outcome disseminated to the society as a whole.

## SANGOLLI RAYANNA STUDY CHAIR

The Chair was established in 2018. The Director of the chair is also working concurrently in the post of Director of Rani Channamma Adhyayana Peetha. The chair was created by a grant of Rs. 2 crores from the Government of Karnataka. The chair has drawn up a list of objectives to carry out its activities.

## Recommendations:

- 1. Seminars/Conferences on anti-colonial struggles in the Bombay- Karnataka region be held.
- 2. Research projects generally on anti-British armed revolts and revolts against feudal lords be undertaken and results published.
- 3. Sources (with emphasis on literary and folk) available on the period be collected, edited and published.



# Strengths:

- The very location of the University in the border district (with Maharashtra, Goa) and multi-lingual, socio-cultural context is a great advantage to impart and disseminate higher education.
- Right from the inception, the University has taken proactive steps to achieve academic excellence just in a span of 10 years the University has constituted one task force and three consecutive Academic and Administrative Committees inclusive of the present one.
- It is heart-warming that the University has started advancing seed money to undertake research projects and the same may be enhanced and continued. At the same time it is also to be monitored by peer review.
- Majority of the Faculty members and the Administrative Staff are vibrant and productive.
- Innovative practice adopted by the examination section in the process of conducting, evaluating, announcement of results and security features incorporated in the marks cards and degree certificates deserve appreciation.
- Some Faculty members are active in research and published papers in journals with high impact factor.
- Good numbers of students have cleared NET/SET examinations.
- Financial discipline is satisfactory, as the deficit in the budget is negligible.
- B.Sc. in Sugar Technology is offered at the UG level to meet the requirements of Sugar industry.

# General Recommendations:

- Need based skill oriented diploma and certificate courses and add-on courses be started to promote employability. Similarly, Inter-disciplinary programmes may be promoted.
- Technology up-gradation of the Library facilities be undertaken on a priority basis.
- Faculty should publish independent single authored books and articles in professional and peer reviewed journals.

- ❖ Teachers be motivated to take up major research projects across faculty.
- ❖ A Language lab to be set up to help the students to improve their communications skill.
- There should be emphasis in the curriculum design and development to strengthen and promote inter disciplinary and multi-disciplinary teaching learning and research like B.Voc and M.voc courses.
- Although the PG Centre at Vijayapura was established way back in 1993 due importance has not been paid to develop it, despite it being a geographically and historically unique region.
- Inter-disciplinary and integrated four/five year's courses be started.
- Collaboration and consultancy be strengthened across disciplines.
- Coaching classes for student to write competitive examinations be strengthened.
- NSS activities should be augmented to fulfil institutional social responsibility.
- Periodic performance appraisals of the teachers and external audit of such reports should be undertaken.
- ❖ It is understood that the land transfer clearance from the Department of Forest could not be completed till today. All-out efforts to be made with priority to convene a meeting of all the concerned to sort out the issue.
- Planning, Monitoring and Evaluation Board (PMEB) be activated and involved in assisting the faculty in relation to submission of Research Proposals.
- Diversity in faculty recruitment needs to be ensured keeping in mind the geographical location of the university.
- Placement cell be made effective, efforts be made to establish the Career Guidance Cell.
- Collaboration of PG departments with NGOS and Industries is to be strengthened.
- Working of PG Programmes in the PG Centers and affiliated colleges is to be reviewed once in every two years in order to strengthen the quality of teaching and learning.

- An expert committee may be constituted to evaluate the working of PG programmes in the affiliated colleges.
- ❖ A Ladies hostel should be constructed on priority for the benefit of large number of girl students.
- ❖ A Research scholar Hostel may be constructed.
- E-Governance is to be strengthened in the administration.
- There can be an on-line 'Help Desk' to addresses the student's grievances.
- Ramps and elevators should be provided to all the buildings to make it disabled friendly.
- Physical Infrastructure should be doubled to facilitate functioning and future growth.
- ICT facilities are to be strengthened commensurate with the requirements of the main stakeholders.
- Steps are to be taken to fill up the sanctioned teaching and non-teaching posts and Positions for the newly started programmes, both on the main campus and P.G. Centers.
- Departmental and Institutional best practices to be highlighted and showcased.
- Student research fellowships may be provided to each department by the University. At the same time awareness is to be created among students to tap fellowship for research from different funding agencies.
- Departmental conferences to discuss various academic and examination matter may be organized every year for Internet of Things (IOT).
- Website to be upgraded on regular basis. An IT officer may take care of this.
- A separate cell for innovation, incubations and Entrepreneurship may be constituted.
- Research regulations may be amended to allow professionals and employees in Industry to pursue joint research programme.
- University level research journal to be started.
- University may start a course on History and tourism on the main campus.
