Compliance Report against the Recommendations of AAA committee.

1. Can take lead, with Physics Department, in establishing a 'Central Research Laboratory'.

Yes, the Dept. of Chemistry is actively collaborating with Dept. of Physics to establish the common Research facilities, which will be formally named as 'Central Research Laboratory'. The following common facilities are available:

- 1. Fourier transform infra-red (FTIR) spectrometer.
- 2. UV-Visible Spectrophotometer.
- 3. Gas sensor.
- 4. Photo-catalytic (UV and Visible) reactor.
- 5. Spray pyrolysis Unit.
- 6. High-temperature Furnace.
- 7. Gouy's balance for Magnetic measurement.
- 8. X-ray source (being installed).
- 9. Gamma-ray detectors (radiation detectors).
- 10. I-V characteristic measurement systems.
- 11. Electron Spin Resonance Spectrometer (being set-up)

Furthermore, the Dept of Chemistry is likely to be funded under DST-FIST-Level-1 programme. The facilities such as Table top X-ray diffraction (XRD), Scanning Electron Microscope (SEM) will be part of the above central facilities.

2. Systematic efforts be made to sign MoUs with Centres of Advanced Studies in India and Abroad. Collaborations with Industries will help, both, research and project works of students.

The faculty members have deputed Ph.D. students to carry out part of their work in the following Institutes.

• Bhabha Atomic Research Centre, Mumbai.

- Basic Science Research Centre, KLE University, Belagavi.
- Regional Medical Research Centre (ICMR Unit), Belagavi.

Dr CC Vidyasagar has presented research proposal to DST in collaboration with Southern Batteries Limited through NCBS, bangalore

Dr. J. Manjanna has visited Iwate University, Morioka (Japan) under International Exchange Programme for Research Collaboration. In continuation of this, a joint Indo-Japan Research Project is submitted to DST-JSPS.

In view of the above active interactions with National and International Institutes, the formal signing of MoUs is under consideration.

3. Quality of PG Courses offered in colleges be monitored and evaluated. Colleges be guided and supported - kind of mentoring.

The Dept. of Chemistry organizes annual PG Teachers and Coordinators Meeting by inviting faculty members and Coordinators from different PG Departments of Chemistry in Affiliated Colleges viz., BK College/Belagavi, GSS College/Belagavi, Maratha Mandal College/Belagavi, JSS College/Gokak, BVV College/Bagalkote and KCP Sci College/Bijapur.

During such meetings, curricular and co-curricular activities including M.Sc. projects are discussed. The suggestions and comments from these faculty members are addressed through our BOS and BOE committees. Also, they are offered to make use of the Research facilities available in Dept of Chemistry, RCU.

Recently, a joint research paper (Hydrometallurgy) was published with BK College/Belagavi.

4. Utilization of budget allotted needs attention.

Unlike during 2015-16, the purchase process through 'Rate contract' and E-tender process in initiated well in advance during 2016-17. All measure are taken for complete and effective use of Budget allotment by convincing the RCU authorities.

5. Culture of Consultancy to be strengthened with a well-defined policy.

In this connection, RCU Research Policy document is published. We follow these guidelines to strengthen the Consultancy with local industries viz., Pharmaceuticals, Polymers and INDALCO (Alumina Industry).

6. Proposed PG Diploma courses are offered on priority basis -as Add on Course.

The syllabus for Add-on PG Diploma course in 'Analytical Techniques' as well as PG Diploma in 'Nanoscience & Technology' is prepared to cater to the need of industrial requirements and upcoming technological applications of materials.

The same will be submitted to RCU authorities for academic approval (Academic Council Meeting followed by Syndicate and Governor's approval) and budget allocation for the same. The modalities (including mandatory Industrial training) are being worked out in this regard.

7. Independent infrastructure to be established with focus on good teaching and research laboratory facilities

All faculty members have been trying to mobilize the external funding through research projects to establish independent research Lab facilities.

For effective teaching, the ICT facilities are used wherever necessary.

In order to establish the independent Chemistry Block, the Department has submitted the required design and layout for common and independent classrooms, Labs, Seminar halls, Store room, etc to the RCU authorities for incorporation in the upcoming Campus infrastructure (after clearing the Land issue with Govt. of Karnataka/Govt. of India).

- 1. Enrollment of 15,000 students is commendable.
- 2. Conduct of both regular and annual camping activities is satisfactory.
- 3. NSS activities are being organized effectively.

Recommendations:


- 1. To have a full-time co-ordinator for the Cell:- The Programme co-ordinator is acting on full-time basis as on additional charge.
- 2. Since government allocation for both regular and special camping purposes is limited, starting of self-financial units needs to be encouraged and conduct activitiesmeaningfully: A mandatory circular has been sent to all colleges for commencement of SFUs and RCU cell has also planned to provide necessary materials to all volunteers and units.
- 3. More volunteers' strength to be got sanctioned by the concerned authority, commensurate with the students' enrollment in the University:- This year an additional strength has been sanctioned by GOK with 1750 volunteers. A fresh proposal would be submitted for strength enhancement.
- 4. Organize awareness camps about health, hygiene, water conservation, air pollution, smoking, alcohol, etc. involving the local people of the surrounding areas. :- This area would be taken care during annual special camps. All the Panchayat and Taluk members are invited to all the camps. Their participation is mentioned in the invitation cards.
- Impact or influence of the organized camps may be reviewed. :- A feed back is collected at the end of the camps and documents are kept by all NSS units in the colleges.
- 6. Organize waste management programmes in the campus:- It is undertaken in collaboration with local authorities and corporations.
- 7. To arrange for university level annual camps in the university campus, during which plantation of saplings, trench making may be undertaken. These activities have significance in maintaining ideal ecological base in the campus. This activity may be done in collaboration with various departments and institutions:- This year our regional directorate has sanctioned NIC to RCU. The plantation would be undertaken in the affiliated colleges.

- 8. Activities conducted both under 'regular' and 'annual camp' need to be stepped up to commensurate with volunteers' strength in colleges and PG Units.
- 9. NSS volunteers need to be exposed yet in a better way, to various state, national and international programmes organized in different places of India.
 :- We are searching the various opportunities to depute the Volunteers to enhance their experience. NSS volunteers have participated in National level seminar too.
- 10. Since NSS is the extension wing of a college / university, adequate care and necessary action has to be taken to ensure that each college has an NSS unit of 50 to 100 volunteers. :- As per the Government norms, we are insisting to start Self Finance Units in all the affiliated colleges. Attempts shall be made to support such units from university side too.
- 11. The environmental/ecological issues need to be focused the most during NSS programs in villages and slums in cities. :- Recently environmental / Green audit has been conducted at university to identify the value of it. The same practices are to be spread at all the colleges. The co-ordinator's visit shall ensure the happening of such practices at all the units. The various university bodies such as CDC, IQAC, SWO, SCST CELL, ensure the best functioning of NSS.
